### **New Business**

Rural Development-Jason finally heard back from Rural Development on Monday. Their attorneys provided comments asking for further clarity. The response to their inquiry will have to be taken up by our Interstate Engineering. Zach has assured us this can be done in a two week turn around. None of the comments or inquiry had anything to do with mound systems.

Engineering Services-Discrepancies were found between our contract with Interstate Engineering versus the monthly billing invoices. The discrepancies were found by Jean, our bookkeeper, via audit. She will take this up with Erika, our attorney. We are requesting that the overcharges be handled by way of a refund versus a credit in order that we can pay on the note since we have not yet received funding from RD.

Rusty-RVSD Update-Jason visited with Rusty just prior from hearing from RD and they discussed a possibility of a merger between GVSD and RVSD in the distant future.

Julie Frye-Mueller Update-Jason called Julie Frye-Mueller to visit with her and give her an update on where we are with RD with the possibility of getting some help as she is our legislator and is aware of our sewer project and funding issues.

Annexation Public Hearing-This meeting is also serving as the required public meeting in regards to the annexation of the two properties at 5995 Reservoir Rd, and 6510 Anderson Rd respectively, which were initially included in GVSD, but at some point were accidentally overlooked and dropped due to clerical errors, so no longer included in the district. Jason visited personally with Andy Kaiser who had no problem with the annexation. Jason will contact the other party on Reservoir Rd. The legal notices regarding the annexation were run one day per week for two consecutive weeks Dec 31, 2022 and Jan 7, 2023 as required by law. The public hearing closed with no comment. A motion by Lucky and seconded by Marlin, to approve the attached resolution conditioned upon approval by the Pennington County Commissioners. No further discussion, motion passed.


