MONTHLY MEETING MINUTES July 10, 2024

Approval of Agenda:

A motion by Lorretta, seconded by Val to approve the July 10, 2024 meeting agenda. No further discussion, all voted in favor and motion passed.

Meeting Minutes:

Motion by Val, seconded by Lorretta to approve the May 29, 2024 Special Public Meeting minutes and the June 12 monthly meeting minutes. No further discussion, all voted in favor and motion passed.

Old Business:

Rapid City Contract- We have not heard anything on this as of yet. We have not received the contract back from the City. Erika will contact the City Attorney on the matter.

Funding Package-This is an \$11.8 million project with \$7.5 million in funding from grants and loan forgiveness.

Sewer Project Schedule-Many steps to go through to get to the final figures.

Open Positions-There are two open positions on the Board of Trustees; no nominating petitions were received. If anyone is interested, please let a board member know or be present at the meeting to volunteer for a position.

Steve Meyers Request-Steve Myers requested discussion about the two contracts with Interstate Engineering and GVSD. We have been instructed by our legal counsel not to discuss this as it is now a legal matter since he has filed a complaint about this and we will need to discuss it with legal counsel.

New Business:

Interstate Engineering Update-Zach reported that they are ready to proceed with survey work and due to the change in design, the engineering contract has to be amended. Scott made a motion to approve moving forward with having Interstate submit an amendment of the contract and finish up with the balance of the surveying under the current contract. Motion seconded by Val, no further discussion, all voted in favor and motion passed.

At 8:58 pm, the board went into executive discussion to discuss Steve Meyers requests for talks on the two contracts with Interstate Engineering and GVSD. We were instructed by our legal counsel not to discuss this as Steve filed a complaint on these matters. It is now a legal matter and will be handled through our attorney. Scott made a motion to go into executive session to discuss these legal matters with counsel-, seconded by Lorretta, no further discussion, all voted in favor and motion passed. Executive Session ended at 9:39 PM

There being no further business, a motion by Scott and seconded by Val for adjournment, no further discussion, all youed in favor and meeting adjourned at 9:40 pm
